By Car:

From the BQE Westbound: Exit at Tillary Street, go two traffic lights and turn left onto Flatbush Avenue. Go four blocks, to just past Fulton Street. Make right onto Nevins Street. Make first right onto Livingston Street.

From Staten Island (via the Belt Parkway):

Take the Verrazano Bridge, then keep right onto the BQE (1-278). Exit at Atlantic Avenue and turn right on to Atlantic Avenue. Go to Bond Street.



Parking:

- Municipal lot on Bond Street between Livingston and Schermerhorn Streets. Entrance on either Livingston or Schermerhorn Streets.
- On Duffield Street between Willoughby and Fulton Streets.
- On Willoughby Street between Duffield and Gold Streets.
- On Gold Street between Willoughby and Fulton Streets.
